Notice of Privacy Policy

Our Privacy Assurance

Thank you for choosing Barton Mutual Insurance Company. In the course of our business relationship with you, we collect information that is necessary to provide our products and services. The privacy of our customers is important to us, and we are committed to its protection. We have developed this privacy policy to inform you of how we handle your personal information in compliance with federal and state law.

We do not disclose any nonpublic personal information about our customers or former customers to anyone, except as permitted by law. No information about a customer will be shared unless the company is allowed or required to do so under applicable laws or unless the customer has authorized Barton Mutual Insurance Company to share the information. The only exception to this rule is if we have actual knowledge that a particular piece of information is of public record.

We do not sell your personal information to third parties.

How We Protect Your Information

We restrict access to nonpublic personal information to employees, agents and third parties on a need-to-know basis. We require those individuals to whom we permit access to your customer information to protect it and keep it confidential. We maintain physical, electronic, and procedural safeguards that comply with applicable regulatory standards to guard your nonpublic personal information.

Information We Collect

Upon your application for a policy, or when handling a claim you present, we may collect and maintain certain nonpublic personal information about you and the members of your household from the following sources:

- Information we receive from you on insurance applications or other forms (such as name, address, social security number, date of birth, marital status and financial information);
- Information about your transactions with us, our affiliates or others (including payment history or account balances);
- Information we receive from a consumer reporting agency (such as credit relationships and history); and
- Information you authorize us to collect.

Information We Disclose

We share information with our affiliates in an effort to fulfill our mission of service to you. We may disclose information to nonaffiliated third parties, but only as permitted by law and for the purpose of fulfilling our obligations to you specifically. Examples are as follows:

- Independent claims adjusters, appraisers, and attorneys during claims handling
- Your insurance agent
- Independent inspectors
- Governmental agencies, in response to subpoenas or threats thereof, or in accordance with statutory requirements
- Our reinsurers
- Other financial service companies for premium payments, but only at your request, and only the information required to enable those alternate methods.

Sharing Information with Affiliates

Barton Mutual Insurance Company encompasses various affiliates¹ that offer a variety of financial products and services in addition to insurance. We may share nonpublic personal information about you with our affiliates in order to provide necessary services for your products or accounts or to tell you about other products or services offered by the companies within our organization that we believe you may find useful.

Your Choice

We are permitted by federal law to share with our affiliates our transaction and experience information with you. It is your decision, however, to opt out of sharing other information with our affiliates. Federal law also gives you the right to limit some, but not all, marketing from our affiliates.

You can request that Barton Mutual Insurance Company not share your personal information with our affiliates by completing and returning the enclosed document limiting sharing and/or marketing. If you previously contacted us and asked us not to allow other Barton Mutual Insurance affiliates to use your personal information, your previous choice still applies and you do not need to contact us again. **YOUR CHOICE TO LIMIT
AFFILIATE SHARING AND/OR MARKETING**

Barton Mutual Insurance Company and its affiliates are providing this notice.

Federal law gives you the right to limit some, but not all, information sharing with our affiliates. We are permitted by law to share with our affiliates our transaction and experience information with you. It is your decision, however, to opt-out of sharing other information with our affiliates.

Federal law gives you the right to limit some, but not all, marketing from our affiliates. You may limit our affiliates from marketing their products or services to you based on your personal information that we collect and share with them. This information includes your income, your account history with us, and your credit score.

Your choice to limit sharing information with our affiliates and/or to limit marketing offers from our affiliates will apply until you tell us to change your choice.

If you are a joint consumer (i.e., two or more consumers that have jointly obtained a product or service), your opt-out direction as a joint consumer may be treated as applying to all of the associated joint consumers.
